

## REFORMS FOR FURTHER DEVELOPMENT OF THE HEALTHCARE SYSTEM AND THEIR IMPORTANCE

**INTRODUCTION:**Literally, renewal and development processes are taking place in our country in order to further improve the standard of living of the population, increase the quality and efficiency of the provided medical services. This, of course, also applies to the emergency and ambulance service of the health care system. After all, President Shavkat Mirziyoyev, in every lecture, speech, and meeting, always insists that in order to please our people, first of all, it is extremely necessary to meet the demand for high-quality medical services. A press conference was held by the Ministry of Economy in cooperation with the Ministry of Health with the participation of media representatives. The conference focused on the recent reforms in this field, in particular, on the issues of further improvement of the organization of the emergency medical service and strengthening of the material and technical base.

**MATERIALS AND METHODS:** When we talk about emergency medical care, we first of all imagine guaranteed, high-quality and fast medical care. Today, in our country, the tasks set for the development of this field and the privileges given, the modern medical equipment allocated for the field, increase the level of scientific research conducted by system specialists, develop and develop new promising methods of diagnosis and treatment in urgent cases, and further expand the opportunities for development. This serves to increase the quality and efficiency of the emergency medical service, to respond to every appeal of the population with practical help, and most importantly, to achieve the satisfaction of our people with the operation of this system.

In this sense, the decision PD-2868 of the President of the Republic of Uzbekistan dated March 16, 2017 "On measures to further improve the organization of the emergency medical service and strengthen the material and technical base", the material of the emergency medical service -improving the technical base, wide introduction of modern scientific and technical tools and information and communication technologies in its practice, is significant as it is aimed at introducing effective mechanisms of rapid cooperation of emergency medical services with emergency services of other ministries and agencies.

**RESULTS AND DISCUSSION:**According to the Decree and Decision of the President of the Republic of Uzbekistan on the further improvement of the quality of urgent and emergency medical care and the strengthening of their material and technical base, the funds allocated for the provision of emergency medical care services with drugs have been doubled, and the central distribution of drugs boarding system has been established. 364 "DAMAS AMB" vehicles were purchased out of 1200 vehicles planned to be purchased for the purpose of providing the ambulance service with vehicles.

The event was organized in order to study the essence of the regulatory documents adopted in the field of urgent and urgent medical care in our country, to familiarize the population with the created opportunities and facilities, and to discuss the tasks and future plans of the system. The emergency medical service aims to provide qualified specialized, high-tech medical services to the population in urgent, fast and urgent cases, to establish an emergency medical care system that meets the world requirements in terms of efficiency, and close cooperation with similar foreign organizations.

The most important thing is that as a result of the wide-scale measures implemented for the development of the field, the emergency medical care system provides highly qualified inpatient care to more than





600,000 patients and outpatient care to more than 1 million patients, as well as more than 7 million calls. is being sold. In addition, ambulance service dispatchers, the main link organizing the work of the medical aid brigade in emergency situations, were retrained, and the requirements for them were increased. Now, in order to strengthen the professional skills and qualifications of the dispatchers, they will be retrained. Because today's dispatcher's task is not only to write down the request and deliver it to the necessary specialist, but in case of need, he should also be able to give advice on the first aid that should be provided to the applicant before the arrival of the emergency medical teams.

Another important aspect of the ongoing reforms is that in order to ensure the rapidity of medical services at the primary medical level and thereby ease the burden on urgent and specialized medical services, recently, two for each of the 60 urban family polyclinics in our capital, a total of 120 "DAMAS" cars were handed over. Now, tasks such as going to patients' homes and performing the most necessary medical procedures, delivering them to a family polyclinic or other medical institution in necessary cases, and providing patronage services are performed on time and without delay. Due to the fact that vehicles move through their territory, situations such as the delay of ambulances due to traffic jams are also avoided.

**CONCLUSION:**During the press conference, the current state of this system, the improvement of the quality and efficiency of the emergency medical service, the expansion of the scope of scientific research in the field of emergency medical care, and the implementation of specific tasks set by the President to deepen international cooperation in this regard were also discussed.
